### **Program Notes**

Thursday, Oct. 5 "Felix Frankfurter and Brown v Board of Education." Brown v. Board of Education of Topeka was a 1954 landmark decision by the U.S. Supreme Court which ruled that U.S. state laws establishing racial segregation in public schools are unconstitutional. The Court's decision in Brown paved the way for integration, was a major victory of the civil rights movement, and a model for many future impact litigation cases. Hosted by Northwest Neighbors Village.

Wednesday, Oct. 11 Movie Group will discuss the following films. *Living* – 2022 on Netflix.

Stars Bill Nighy. Overwhelmed at work and lonely at home, a civil servant's life takes a heartbreaking turn when a medical diagnosis tells him his time is short. He continues to search for meaning until a simple revelation gives him a purpose to create a legacy for the next generation. *Hopscotch* – 1980 on Amazon Prime. In this comedy, CIA operative Miles Kendig (Walter Matthau) deliberately lets KGB agent Yaskov (Herbert Lom) get away, his boss threatens to retire him. Kendig beats him to it by destroying his own records and traveling to Austria where he begins work on a memoir that will expose all his former agency's covert practices. The CIA catches wind of the book and sends other agents after him, initiating a frenetic game of cat and mouse that spans the globe.

Thursday, Oct. 19 Financial Literacy: "Will You Outlive Your Money?" This analysis looks at how much you have in savings and considers your life expectancy. The number one concern among retirees is that they may outlive (i.e., live to be 100 years old) their money or need to use it all on long term care. There are some strategies to consider.

# Conversation with Councilman Canek Aguirre

On Oct. 25, at 1:00 pm, in the latest of a series of interviews of Alexandria civic leaders, Howard Weiss will moderate an interview with Councilman Canek Aguirre on Zoom. The interview will last 60 to 75 minutes. It will conclude with a 15-minute question and answer segment.

Councilman Aguirre was first elected as Alexandria's first Latino councilman in 2018 and is currently serving his second term through 2024. The son of Mexican immigrants, he is a native of Los Angeles. Prior to serving on the council, he served on numerous municipal and regional boards and commissions. Aguirre was a community activist and heavily involved in Alexandria schools and the integration of minority students into the educational system. He has also focused on affordable housing, crime and policing issues and community development, zoning and transportation concerns. Canek has a Bachelor of Arts degree from the University of North Carolina at Chapel Hill.

## **DOT Paratransit Program**

The Alexandria Department of Transportation ("DOT") operates a paratransit program that offers a convenient, inexpensive alternative to ride-sharing companies and cab companies senior card discount program. Senior Services of Alexandria manages this service. To be eligible for this service, you must complete a form demonstrating that you are disabled in some way (e.g., vision difficulties or legs and back issues). The form is short and simple. A doctor or physical therapist must certify your responses. You do not need to be using a wheelchair, walker or cane.

Membership entitles you to free trips on 24 hours' notice within Alexandria and \$4.00 to \$6.00 trips to Washington D.C., Arlington, Fairfax County, Fairfax or Reagan and Dulles airports. For further information and the form, call 703-746-4084.



# Ten Drugs Subject to Medicare Price Negotiations

In a first for the program, Medicare has released the names of the 10 drugs that will be subject to price negotiations this year. Medicare's authority in this matter is the recently enacted Inflation Reduction Act of 2022 signed into law in August 2022. The list is: Eliquis (prevention and treatment of blood clots), Jardiance (diabetes and heart failure), Xarelto (prevention and treatment of blood clots and reduction of risk with coronary or peripheral artery disease), Januvia (diabetes), Farxiga (diabetes, heart failure, chronic kidney disease), Entresto (heart failure), Enbrel (rheumatoid arthritis, psoriasis, psoriatic arthritis), Imbruvica (blood cancers, Stelara (psoriasis, psoriatic arthritis, Crohn's disease, ulcerative colitis). In addition, the following diabetes control drugs are included: Fiasp; Fiasp FlexTouch; Fiasp PenFill; Novolog FlexPen; Novolog PenFill.

Drug companies with a selected drug for the negotiation program and the public will have an opportunity to submit data and information on the selected drugs to the Centers for Medicare and Medicaid Services (CMS) by October 2023. The negotiation period ends on August 1, 2024.

CMS will select up to an additional 15 drugs for negotiation in future years.

# Staying Healthy in the 2023-2024 Flu Season

Don't let seasonal respiratory illnesses get in the way of your 2023-2024 fall and winter seasons. Here are the 3 things you need to know for a healthy year:

- COVID-19, the flu, and RSV are all respiratory illnesses that are expected to spike in the fall and winter. Older people, people with underlying health conditions at higher risk for severe illness.

- Talk to your doctor now to plan for getting vaccines this season and staying healthy.

Sandy shared their family experiences hosting many Japanese medical scientists doing research at the University of Iowa College of Medicine. All participants were glowing with the warmth of the event and felt hopeful thinking about world peace.

# Why is a QCD Better than a Charitable Deduction?

Many donors find that a Qualified Charitable Deduction (QCD) provides greater tax savings than the cash donations claimed as charitable contributions claimed on a tax return. Really? For many of us, our itemized deductions are less than the standard deduction allowed on a federal tax return since the tax laws changed in 2018. By making a charitable donation directly from a qualified retirement account, we may be able to reduce our taxable income. This is especially true if we have reached the age where we are required to take an annual distribution from that retirement account, or RMD. A QCD meets the RMD requirement and is not reported as taxable income.

There are a few caveats: Many financial custodians will provide checks specifically for this purpose. Others will require you to request a check(s) for the QCD by a specific deadline prior to the end of the year. That deadline may fall in November. As always, consult with your tax advisor. You may be pleasantly surprised to learn that this is a better strategy for you.
